Introduction

This policy statement sets out the arrangements for St Joseph's Catholic Academy ("the Academy") in managing provider access to the Academy to give students information about the provider's education or training offer. This complies with the Academy's legal obligations under Section 42b of the Education Act 1997. It sets out:

- procedures concerning access requests;
- the grounds for granting and refusing requests for access;
- details of premises or facilities to be provided to a person given access.

Statutory requirements

Schools must ensure an opportunity for a range of education and training providers to access students in Years 7 to 13 to inform them about approved technical education, qualifications or apprenticeships. Schools must also have a policy statement that outlines the circumstances in which education and training providers will be given access to these students. This is outlined in section 42b of the Education Act 1997. This policy shows how the Academy complies with these requirements.

Student entitlement

Students in Years 7 to 13 at St Joseph's Catholic Academy are entitled to:

- find out about technical education qualifications and apprenticeship opportunities as part of our careers programme, which provides information on the full range of education and training options available at each transition point;
- hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options events, assemblies and group discussions and taster events;
- understand how to make applications for the full range of academic and technical courses.

For students of compulsory school age, these encounters are mandatory. There will be a minimum of two encounters for students during the 'first key phase' (Years 8 to 9) and two encounters for students during the 'second key phase' (Years 10 to 11). For students in the 'third key phase' (Year 12 to 13), two more provider encounters are available during this period, which are optional for students to attend.

These provider encounters will be scheduled during the main Academy hours, and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers:
- explain what career routes those options could lead to;
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and students from the provider);
- answer questions from students.

Safeguarding

Premises and facilities

The Academy will make the Main Hall, Library, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The Academy will also make available AV and other specialist equipment (where available) to support provider presentations. All presentations must be approved by the Headteacher to keep with the Catholic nature of the Academy. This will all be discussed and agreed upon before the visit with the Careers Leader or a team member.

Meaningful online engagement is also an option, and we are open to providers that can provide live online engagement with our students. Providers are welcome to leave a copy of their prospectus or other relevant course literature at the Careers Library, managed by the Careers Leader. The Careers Library is available to all students at lunchtime, break times, and 1:1 career guidance meetings.
